REGULAR TOWN BOARD MEETING
February 11, 2026

Chairman Forrest Johnson opened the Town of Dunn Board meeting at 7:00 pm on Wednesday, February 11, 2026 at the Town Hall at N2713 State Road 25, Menomonie. Board members present: Forrest Johnson, Brad Ullom, Kaley Walker, Arlene Cartwright and Sally Rasmussen.

1. Meeting Minutes: **It was moved by Walker and seconded by Ullom to approve the regular Town Board meeting minutes of Wednesday, January 14th, 2026**

9. Downsview Day Update: There was a meeting on Monday and no email has arrived as to the outcome of that meeting. No members of the Town of Dunn were present at the meeting.

11. Road Maintenance Report: All Grants have expired (ARIP, ARPA and R2R) and closed. A citizen complained about a culvert flooding their land. Chairman talked to the land owner and told him the towns responsibility did not go further than the right of way and that he needed to recreate a waterway that was removed by him when he purchased the property.

13. Fire Report: There was a meeting last month to get an Innovation Grant to help with Fire and EMS Payments. Next meeting will be Monday, February 16, 2026. A New, Used Fire Truck was purchased and will be arriving by the end of the month.
