Chairman Forrest Johnson opened the Town of Dunn Board meeting at 6:34 pm on Tuesday, April 21, 2026 at the Town Hall at N2713 State Road 25, Menomonie. Board members present: Forrest Johnson, Brad Ullom, Kaley Walker, Arlene Cartwright and Sally Rasmussen

1. Meeting Minutes: **It was moved by Walker and seconded Ullom approve the Town Board meeting minutes of Wednesday, March 11, 2026**
2. Public Comment: None
