Chairman Forrest Johnson opened the Town of Dunn Board meeting at 7:08 pm on Wednesday, August 12, 2020 at the Town Hall in Downsville. Board members present: Forrest Johnson, John Miller, Dennis Weber, Sally Rasmussen, and Arlene Cartwright. Town Citizen: John Ohman
